

Terms and Conditions for the Boat Show Offer:

This Offer is only valid for orders placed during the following dates:

16th May –08:30 AEST and 9th June 23:59 AEST (“**Offer Period**”) via Raymarine Approved Dealers in Australia.

The following terms and conditions apply to this Boat Show Offer. Instructions for valid purchases form part of the Terms and Conditions which you will be deemed to have accepted if you participate.

1. OFFEROR

- 1.1. Boat Show Offer is provided by Raymarine, a business unit of FLIR Maritime Asia Pty Ltd with registered address Suite 1.01, 26 Rodborough Road, Frenchs Forest, NSW 2086 together “**Raymarine**”, strictly via participating Approved Dealer & Approved Retailer Network “**Approved Dealer**”. A listed Approved Dealer may not be providing this Offer.
- 1.2. Individual customers, boat owners, general public taking advantage of Boat Show Offer (“**End Users**”) may take part in this Boat Show Offer strictly via a participating Approved Dealer.

2. BOAT SHOW OFFER OVERVIEW

- 2.1. These terms and conditions set out the terms for participation in Raymarine Boat Show Offer.
- 2.2. The Offer provides End Users the opportunity to take advantage of any of the following promotional deals (“**Offer**”) in separate transactions:
 - a. Free Gift of Quantum Radar when, two (2) Axiom12+ units, or two (2) larger screens (“**Qualifying Product**”) are purchased in one transaction; or

- 2.6. Raymarine may also refuse to accept any orders placed under the Offer (or cancel any such orders prior to dispatch) where we have reasonable grounds to suspect illegal or fraudulent activity.

3. BOAT SHOW OFFER

4. FURTHER QUALIFYING PRODUCT DETAIL

- 4.1. Free Gift of Quantum Radar (Part number T70243: Quantum Q24C 18" Radar with 10m Power and 10m Data Cable) when Qualifying Product, two (2) Axiom12+ Multifunctional Displays are purchased;
- a. End Users are permitted to alternatively purchase two (2) larger Multifunctional Displays and still receive Free Gift.
 - b. For an additional cost, End users may upgrade Free Gift to alternative Raymarine Doppler or Cyclone Radar. The cost to upgrade from standard Free Gift (Quantum Radar), to either Quantum Doppler or Cyclone, will be the difference in the standard RRP of the Free Gift Quantum Radar and the RRP of the upgraded radar. 5. RIGHTS

- 6.3. Raymarine and Approved Dealer will only give End User personal information to other third parties where the law either requires or allows for the purposes of fulfilling its obligations in relation to this Offer. .
- 6.4. Data Protection: By participating in the Offer, End User consents to the transfer of their personal data to the Data Controller and the use of their personal data for the purposes of the administration of this promotion and any other purposes to which the End User has consented. - 7.8. Raymarine reserve the right to cancel all or part of this Offer at any time.
- 7.9. This Offer may not be used in conjunction with any other Raymarine offer except at the sole discretion of Raymarine.
- 7.10. End Users should retain a copy of their receipt as proof of purchase.
