### 1. ELIGIBILITY

The Raymarine 'Earn Your Strikes' Free Fishing Trip Giveaway (the "Sweepstakes") is open to legal citizens currently residing in the 50 United States and the District of Columbia who are at least 18 years old (19 in Alabama and Nebraska, or 21 in Mississippi) as of the date of Sweepstakes entry. Citizens of Puerto Rico and Canada who are the age of majority or older in their jurisdictions of residence are also eligible. Raymarine as a business unit of Teledyne FLIR Maritime US, Inc. Normal Internet access, phone, and usage charges imposed by your online or phone service may apply.

Limit one (1) entry per person per method. **ADDITIONAL ENTRIES MAY BE DISQUALIFIED.** Participants may enter through both methods (rebate submission and no-purchase entry) for a maximum of two (2) total entries per person.

By entering this Sweepstakes, you signify and agree that your entry and any other materials you submit in connection with this Sweepstakes (together, the "Entry Submission" or the "Submission") may be posted on Sponsor's website and/or other social media sites or applications associated with the Sweepstakes in a manner that is consistent with these Official Rules. All potential winners are subject to verification before the prize will be awarded.

Each participant acknowledges and agrees that such participant will not be entitled to any compensation as a result of Sponsor's use of any such similar or identical material. Each participant acknowledges and agrees that the Sponsor does not now and shall not have in the future any duty or liability, direct or indirect, vicarious, contributory, or otherwise, with respect to the infringement or protection of the copyright in and to the Submissions.
